# ACKNOWLEDGEMENT OF RISK AND RELEASE OF LIABILITY

### Every Person Must Read and Understand this Waiver Before Participating in Canine Activities

The following waiver of all claims, release from all liability, assumption of all risk, agreement not to sue and other terms of this agreement are entered into by the Participant with and for the benefit of

**North Thompson Stock Dog Association (NTSDA)**, its directors, officers, employees, volunteers, business operators, agents, and site property owners or lessees (the "Host").

Without limiting the generality of the foregoing "Canine Activities" includes but is not limited to stock trials, demonstrations or instructions provided by the "Host" to the Participant.

### Initial Each Item below after Reading and Understanding each Item:

- \_\_\_\_\_ 1. I am aware that there are inherent dangers, hazards and risks ("Risks") associated with "Canine Activities" and injuries resulting from these "Risks" are a common occurrence. I am aware that the "Risks" of "Canine Activities" mean those dangerous conditions which are an integral part of "Canine Activities", including but not limited to:
  - (a) the propensity of any canine to behave in ways that may result in injury, harm or death to persons on or around them and to potentially collide with, bite or attack other animals, people or objects;
  - (b) the unpredictability of a canine's reaction to such things as sounds, sudden movement, tremors, vibrations, unfamiliar objects, persons or other animals and hazards such as subsurface objects;
  - (c) the potential for other participants to behave in a negligent manner that may contribute to injury to themselves or others, including failing to act within their abilities to maintain control over a canine.
- \_\_\_\_\_ 2. I freely accept and fully assume all responsibility for all "Risks" and possibilities of any and all personal injury, death, property damage or loss resulting from my participation in "Canine Activities".
- \_\_\_\_\_ 3. I agree that although the "Host" has taken steps to reduce the "Risks" and increase the safety of the "Canine Activities", it is not possible for the "Host" to make the "Canine Activities" completely safe. I accept these "Risks" and agree to the terms of this waiver on behalf of the Youth Participant, even if the "Host" is found to be negligent or in breach of any duty of care or any obligation to me in my participation "Canine Activities".
- \_\_\_\_\_ 4. In addition to consideration given to the "Host" for my participation in "Canine Activities", I and my heirs, next of kin, executors, administrators and assigns (collectively my "Legal Representatives") agree:
  - (a) to waive all claims that I have or may have in the future against the "Host";
  - (b) to release and forever discharge the "Host" from all liability for personal injury, death, property damage, or loss resulting from my participation in the "Canine Activities" due to any cause, including but not limited to negligence (failure to use such care as a reasonably prudent and careful person would use under similar circumstances), breach of any duty imposed by law, breach of contract or mistake or error in judgment of the "Host", and
  - (c) to be liable for and to hold harmless and indemnify the "Host" from all actions, proceedings, claims, damages, costs, demands, including court costs and costs on a solicitor and own client basis, and liabilities of whatsoever nature of kind arising out of or in any way connected with my participation in "Canine Activities".

I agree that this waiver and all terms contained herein are governed exclusively and in all respects by the laws of the Province or Territory of Canada in which the "Canine Activities" are provided by the "Host". I hereby irrevocably submit to the exclusive jurisdiction of the courts of that Province or Territory of Canada and I agree that no other court can exercise jurisdiction over the terms and claims referred to herein. Any litigation to enforce this waiver will be instituted in the Province or Territory of Canada in which the "Canine Activities" are provided by the "Host".
